In February 2021, Kim Campbell was promoted to Deputy Sergeant of Arms, serving the Office of the Sergeant at Arms and U.S. House of Representatives, where she is actively elevating the professionalism of the Office of the Sergeant at Arms workforce.



As the Sergeant of Arms' proxy, Ms. Campbell provides operational and management oversight for Immediate Office Administration, Emergency Continuity Preparedness, Protocol and Chamber Operations, House Security, Police Services and Information Services. She advises on policies and procedures, resolves technical problems, makes staff assignments, advises on sensitive and confidential coordination issues; she also takes part in strategic planning, emergency preparedness planning, and other high-level projects. She serves as the Office's principal liaison to the U.S. Capitol Police, and engages with numerous stakeholders regarding security of the House Office Buildings and Members of Congress. She supports House Recovery Operations, coordinates U.S. Capitol Police investigations of threats on Members of Congress. She serves as a critical liaison to military, Federal, and local police agencies that provide intelligence data on foreign and domestic terrorism directed at the U.S. Congress. Prior to her current appointment, she served as Assistant Sergeant and Intergovernmental Liaison, bringing key players and stakeholders together in providing accountable security services and policy.

As a Senior Executive with nearly 30 years of prior experience as a Special Agent for the U.S. Secret Service (USSS), Ms. Campbell was admitted to the Senior Executive Service in June 2017. Her most recent assignment was as Special Agent in Charge of the USSS Office of Government and Public Affairs, Liaison Division (2014–2019), where she enhanced the performance, diversity, and advancement of personnel at the USSS Liaison Division, making it the agency's top-rated division with the highest reported morale. Previously she led a transformation of the agency's Freedom of Information Act (FOIA) and Privacy Act (PA) operation. Detailed as Special Advisor, she also developed recommendations for transforming the Department of Veterans Affairs (VA) \$1B Uniformed Police Program. In response to the 2013 Navy Yard shooting, she delivered enhanced security for the VA's 153 facilities. through scenario-based, law enforcement training coupled with employee exercises across the VA.

Recognized as a leader in security planning and policing, protocol and administration with expertise in organizational planning, resource accountability and diplomatic relationship management, she has provided location and event security while maintaining respect and decorum for the institutions and persons served. She served on Presidential Protective Details for Presidents William J. Clinton and George W. Bush, and First Lady and Senator Hillary Rodham Clinton. Most recently, on behalf of the Office of the Sergeant at Arms, she has traveled with House Speaker Nancy Pelosi and has escorted Chief Justice John Roberts to attend the State of the Union address. Ms. Campbell holds a M.S. in Management from Johns Hopkins University as well as a B.S. in Psychology from the University of Florida. In addition, she has completed leadership training at Harvard University's Kennedy School of Government and elsewhere. She is a recipient of the George Washington University Public Leadership Award (2015), and has received numerous other awards for superior and outstanding performance.
